Sub : Annual Maintenance Service with Resident Service Engineer
for Computers & Peripherals – Regarding.

This Institute invites sealed tenders from interested firms / parties for providing comprehensive annual maintenance service for computers and peripherals with resident service engineer on contract basis for a period of one year.

The tenders to be submitted in sealed envelopes superscribing "**TENDER FOR A.M.C. OF COMPUTERS & PERIPHERALS**" alongwith a refundable *Earnest Money Deposit* of **Rs. 2500/-** by way of Demand Draft in favour of "**Director, C.M.E.R. & T.I.**" payable at Jorhat should reach the Director, Central Muga Eri Research & Training Institute, Central Silk Board, Lahdoigarh, Jorhat – 785700 on or before **20-11-2017** latest by **1:00 PM**. Quotation not accompanied with E.M.D. shall summarily be rejected. The E.M.D. will not bear any kind of interest.

The tenders will be opened on the same day (i.e. 20-11-2017) at 2:30 PM in the presence of the parties or their authorized representatives as may choose to be present. If the date of opening of tender happens to be a holiday, the tenders will be opened on the next working day at the same time. The parties should keep their offered bid validity open up to 6 (six) months from the last date of opening of the tender.

Before submitting the tender, the bidder should go through the terms and conditions stipulated by the Institute given in **Annexure-I**. They may make on the spot inspection of the systems on any working day between 10:00 AM to 3:00 PM before the last date for submission of tender..

The bidder should enclose the copies of orders issued by any other Government organizations where similar machines are being maintained by them through A.M.C. or otherwise.

The Institute is not bound to accept the lowest tender and reserves the right to reject any or all the tenders without assigning any reason whatsoever. The decision of the Director, CMER&TI, Lahdoigarh will be final and binding on all the parties.

The concerned bidder can obtain the reason for rejection of his bid, bidding procedure and conditions of the bid, if he chooses to do so by giving a request in writing.

ANNEXURE - I

Terms & Conditions for Comprehensive Annual Maintenance Service:

- The party must be in the field of Computers and peripherals Servicing for at least 3 years.
- 3 years servicing credential certificate must be submitted alongwith the quotation.
- The Maintenance contract for both Computers & peripherals should be from single party.
- Performance Security will be deposited at the time of execution of the agreement within 10 days of placing of order for AMC and the party shall deposit Security of 10% of the total A.M.C. charges. Security should be deposited in the form of Demand Draft drawn in favour of *Director, C.M.E.R.& T.I.* . Performance Security will be released after the closure of A.M.C. period. No interest shall be payable for the amount of Security Deposit.
- The party shall maintain the said computers and peripherals including all hardwares in the central processing units, monitors, keyboards, mouse for their smooth and efficient integrated functioning for a period of one year.
- The maintenance by the party shall be done satisfactorily in such a way that the performance of each item will remain as original and will conform not below to its present configuration.
- One suitably qualified/ experienced engineer should be deputed on full time basis to attend problems during working hours of the institute on all working days.
- The party shall provide comprehensive maintenance of the items, which includes free repairs and free replacement of spare and components, if required, except consumable items (like Ribbon, Toner Cartridge). In no case, any amount will be paid, barring the charge of A.M.C. Preventive maintenance of the machines at regular intervals is also to be ensured.
- The A.M.C. will be on-site. Whenever a Computer / Peripheral will go out of order or will show any problem, the same will be communicated by any means to the party. The party will rectify the faults within 3 (three) days time, failing which they will have to provide, respective items of either equivalent or higher configuration, as stand-by, for smooth functioning of institute works. If the party fails to provide standby, then penalty of Rs.200.00 per day may be imposed.
- If the delay in proper rectification is more than 10 (Ten) working days from the date of receipt of the first communication, the competent authority of this institute will have the right to discontinue the contract by just informing the party, in which case the **Security Money Deposited by the party will be forfeited.**
- The spares and components to be provided by the party, if any, should neither be inferior in quality to nor less in configuration than the existing ones. If it is necessary to repair any existing machine or any component off-site, the same may be done after providing a stand by machine / component so that routine works are not hampered.
- The Institute shall provide proper power source and standard power connection for operating Computers and Peripherals. The Institute will ensure that the components of the systems are not opened or removed by persons not authorized by the party. Rectification of the damage due to deviation from these and the same caused by other abnormal situations like short-circuiting, fire, theft, riots, accidents, natural calamity etc., if any, can be charged extra by the party at the prevailing market rate.
- The charges for A.M.C. will be remain fixed throughout the period or extended period due to delay in providing services, if any. Payment against the A.M.C. will be made by the Institute to the party at the rate of half of the total A.M.C. charges reduced by TDS at prevailing rate on Half-yearly basis after completion of each six month period along with extended period due to delay in providing services, if any. Income Tax chargeable at source, as per rules, shall be deducted at the time of settling the bill. A certificate to this effect shall be issued in Form-16A.

- Any addition or deletion of computer, Peripheral for the purpose of AMC should be possible on pro-rata basis.
- EMD of unsuccessful tenders will be refunded after finalization of A.M.C. and the EMD of successful bidder will be retained till completion / execution of the assigned work. EMD will be forfeited in case the agency withdraws after selection.
- Tender received from the parties after the deadline for submission of tender will be rejected and /or returned un-opened to the tenderer.
- Rate should be quoted for all types of Computers, Printers , Scanners and service engineer separately. The party should quote the rates as per format provided.
- Items which are not covered under A.M.C. should be clearly mentioned in the tender.
- Applicable GST and other charges if any should be indicated separately.
- The bidder shall submit one copy of the tender document with each page signed and stamped, as a proof to confirm the acceptance of entire terms and conditions of the tender notice by the party.
- Photocopy of the PAN card of the firm, GST registration certificate / document, trade license must be enclosed with the bid.
- All statutory provisions under the labour laws shall be complied with by the bidder and they will be responsible for such compliance.
- The Director for any reason whatsoever may terminate the contract before its expiry, by issuing 15 days prior notice. In the event of such termination of the contract, payment of the service rendered upto the period of termination, subject to deduction of any dues, other recoveries etc.
- The Director or his authorized officer reserves the right to accept or reject and or all Quotation(s) without assigning any reason whatsoever.
