
Terms & conditions:

- Interested Firms/persons may inspect the said vehicle physically on any working day between 10 am to 3 pm at the above mentioned office premises.
- The disposal of vehicles shall strictly be on " AS IS WHERE IS CONDITION BASIS " and no guarantee or certificate of its worthiness or quality will be given by the Central Silk Board.
- Firms/persons who are interested to participate in the public auction should deposit EMD amount of Rs.2220.00 (Rupees Two thousand Two Hundred Twenty) only in the form of D.D/Bankers cheque only drawn in favour of Director, CMER&TI, Jorhat on or before 12-12-2016 at 10 am and obtain proper acknowledgement. The EMD will not be accepted beyond the prescribed date & time. EMD will not bear any interest.
- The quotationer also requires to submit EMD for Rs.2,220.00 (Rupees Two Thousand Two Hundred Twenty only) in the form of DD/Bankers cheque only drawn in favour of Director, CMER&TI, Jorhat on or before 12-12-2016 at 10 am and obtain proper acknowledgement. The EMD will not be accepted beyond the prescribed date & time. EMD will not bear any interest.
- No parties will be allowed to participate in the public auction without submission of the required EMD.

The successful bidder should deposit full amount of the bid amount within 2 working days either in cash or in the form of DD/ Banker Cheque drawn in favour of Director, CMER&TI, Jorhat and delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of his/their residential status (Ration Card/Voters Identity Card/ Aadhaar card etc. in case of individual and Registration Certificate in case of firms etc.)
8. The disposed vehicle should be lifted/removed by the successful bidder within 24 hours of depositing the money at their own expenses. No assistance/transportation will be provided by the Institute. Permission to take out the disposed vehicle from CMER&TI, premises will not be allowed on General Holidays, Second Saturday & Sundays or after the working hours etc.
