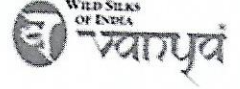

Non rusting metallic eye let of 15 mm dia on tarpaulin cloth at 10 locations. 1. Size : - L- 25 feet X B – 25 feet X H- 15 feet 2 Size : - L -35 feet X B – 25 feet X H- 15 feet 3. Size : - L- 40 feet X B- 30 feet X H -15 feet 4. Size: -L- 40 feet X B- 25 feet X H – 15 feet 5. Size: L – 4 feet X B- 2 feet .
