(1) DRIVER-1 No. The driver must possess a valid Driving License (Heavy) issued by concerned District Transport

: Authorities.

: Minimum class VIII standard pass

: Between 18-40 years as on 01.01.2018

: Minimum 3(three) years experience in Driving of Heavy Vehicle under Govt/Semi Govt/Institute/Farm etc.experience certificate to this effect must be submitted to drive heavy/light vehicles

The rate of wage quoted in the quotation should be less than the minimum wages notified by the Central Government for supply of Driver-1 no. A copy of the latest notification issued by the Central Labour Commissioner (Central), Govt.of India, New Delhi to be enclosed along with the rate quotation. The agency must comply with the provision of contract labour Act 1970 for supply of Driver 1 No.

The manpower Agency must have a valid Licence obtained from Labour Department to supply the manpower to different organizations.

The Manpower Agency must possess the EPF Code Number to deposit EPF which should be deducted at source from the wages of hired Driver-1 No to the Employees Provident Fund Organization.

The agency must register themselves with the concerned authorities to deposition of ESI in respect of Driver-1 no.

PAYMENT:
