01. The Vehicle should be registered as Taxi or public transport vehicle.
02. The vehicle should be with valid documents and in smooth running condition.
03. In no circumstances, the office will be responsible for any damage or disorder of the vehicles during journey period.
04. The Driver should have valid driving licence and not addicted to alcohol or any other intoxicating drugs and has no pending cases of accident in any police station.
05. Validity: The rate should be valid for Minimum 12 months from the date of approval.
06. Payment:- The payment will be made only after completion of the journey and on submission of bill in duplicate duly certified in the Log Book statement by the Officer using the vehicle.
07. TDS and other statutory levies will be deducted from the bill at source as per rule.
08. copy of the PAN card should also be submitted along with the quotation.
