

Minutes of Third Coordination meeting of CMER&TI, Lahdoigarh and MESSO, Guwahati held on 29/11/2022 at MESSO, HQ, Guwahati

The 3rd coordination meeting between CMER&TI, Lahdoigarh and MESSO, Guwahati was held on 29/11/2022 at conference hall of MESSO, Guwahati. Dr. K. M. Vijaya Kumari, Director, CMER&TI and Dr. P. Borpuzari, Sc-D & Head, MESSO along with Scientists from both institutes were present during the meeting. The discussion/decisions taken during the meeting are as follows:

1. Stock replenishment committee members to visit forest areas of Pasighat/ Siang, Arunachal Pradesh or any other potential areas to collect wild muga stock by February, 2023. Further, multiplication will be as per norms. Stock replenishment committee will finalize the location and period of survey.
2. The feedback report of 250 g muga dfls supplied on second week of June, 2022 to CMER& TI, Lahdoigarh is yet to be submitted.
3. MESSO will conduct the grainage activities/ crossing work of replenishment stock with available breeding guidance/protocol of CMER&TI, Ladoigarh, Jorhat. The replenishment stock rearing of muga silkworm of 2nd generation will be conducted in different locations under the control of CMER&TI as mentioned below:
 1. 100 dfls in RSRS, Manipur
 2. 100 dfls in CMER&TI, Lahgoigarh farm
 3. 50 dfls by pvt. Farmer under CMER&TI, Lahgoigarh
4. Regarding the Muga conservation site i.e. Damalgiri state farm at Tura Meghalaya, the Govt. of Meghalaya has requested to release the land as presently not being utilized by CSB. Director of CMER&TI, and Scientist-D & Head, MESSO advised nominated committee members to visit the Damalgiri farm and submit the feasibility report by December 2022.
4. As per the indent of muga and eri dfls for various projects, TOT, OFT and OSTs of CMER&TI, Lahdoigarh should be placed mentioning season specific indent by the end of February, 2023. Required dfls to be supplied from MESSO, Guwahati to concern indenter of CMER&TI in the time schedule.
5. For *in situ* and *ex situ* conservation of muga the Director of CMER&TI, and Scientist-D & Head, MESSO suggested that the programme should be carried out seriously. The conservation site in Meghalaya needs to be visited and the status report of *in situ* and *ex situ* conservation sites to be furnished to CMER&TI, Lahdoigarh. Further, the concerned

DoS Assam, Arunachal Pradesh & BTC may be requested to submit the present status reports of the conservation sites to CMER& TI, Lahdoigarh.

6. CMER&TI, Lahdoigarh was requested to arrange payment of long pending DCB arrears as early possible, the internal audit and C&AG audit team has given a serious query for realization of long pending outstanding dues from all defaulting agencies.

7. A meeting for discussion on Seed Action Plan was suggested with MESSO, CMER&TI, Lahdoigarh and State Sericulture Departments in the month of March, 2023.

8. For disease surveillance and effective management, a project has already been proposed in RAC meeting from CMER&TI, Lahdoigarh in collaboration with MESSO and different DOS of N.E. States. The project is waiting for coding by RCS, Bangalore.

8. Maintenance of C2 breed to continue at CMER&TI; EBSF, Topatoli and farmer's level.

9. Next coordination meeting is proposed in January, 2023.

The meeting was ended with vote of thanks from Dr. Hridya H. Scientist-C, MESSO.
