1.	Nylon Rearing Net	10 nos	 Length of the Net – 30 feet Breadth of the Net – 25 feet Height of the Net – 15 feet HDPE netting, weight of the net should be more than 6.7kgs per 100 meter. Mesh size – 2mm*2mm Double Stitching along with all joints of HDPE netting. Reinforced at every 5 feet on length and width on top. Tying Loops to be provided at every 10 feet. Tapping Door for entry. Non rusting metallic eye/ring of 15mm diameter on tarpaulin cloth at 10 location.

The quotation should be addressed to the **Director**, **CMER&TI**, **CSB**, **Lahdoigarh** in a sealed envelope super scribing "Quotation for Supply of Nylon Rearing Net."
